The Thompson Court No Parking Law

- **Section I.** Section 175-34, Schedule IX of the Code of The Town of North Greenbush is hereby amended as follows:
 - A. There shall be no parking on the North and South sides of Thompson Court for a distance of 200 feet extending Eastward from the intersection of Thompson Court and Route 4.

Section II. The law supersedes section 175-17 and section 173-34, of the Code of North Greenbush to extent inconsistent therewith.

Section III. This law shall take effect immediately upon filing with the NYS Department of State.
